On the subject of Neighbourhood Plans, our Borough Councillor pointed out the Sheepy Parish had a good example of a Neighbourhood Plan, and the Vice Chair of Sheepy Parish Council, who was present at the meeting, gave a brief history of the making of the plan. The Vice Chair of Sheepy Parish Council suggested that the MP joins a combined meeting of the Parish Council and Steering Group, and this suggestion was discussed at the Parish Council meeting on 7 th July 2020.
